

## History Plus - Language Searching

History Plus searching has been enhanced to include natural language search options that enable you to use search operators and other punctuation in order to run more detailed searches and generate the results you need.

Natural language search options extend the range of search options available; which, along with the existing search options, enable comprehensive searching of documents and their contents. Language searching

is available in the Finder and the History screen of a file. This feature is not yet available in Outlook Plus, the floating Finder or the Query Wizard. Language searching will be included in a future Visualfiles release.

## Visualfiles SOS Contact 1.0 Integration

Visualfiles SOS Contact 1.0 is a solution based on the existing IPI Link with SOS Practice Management (SOS PM).

The solution supports the two-way integration of multiple address contact records between Lexis Visualfiles and SOS PM. It is aimed at Visualfiles users who already integrate with SOS PM who want to extend the existing contact address functionality. This feature is existing functionality that has been tested and certified by LexisNexis QA.

Visualfiles SOS Contact enables a closer integration between SOS Practice Management and Visualfiles. Key features of the integration include:

- The ability to create and maintain multiple INDIVIDUALS to a PRIVATE client.
- The ability to create and maintain multiple OFFICES to a COMMERCIAL client.

Visualfiles SOS Contact 1.0 is compatible with Visualfiles 2.02.090709 or later, and SOS PM 5.17.13, and can be implemented on any environment that incorporates these products.

## Visualfiles Installer Updates

It is now possible to use a central Visualfiles API Configuration file to store the API parameters, which eliminates the need to run Visualfiles before Outlook on machines with new installations of Visualfiles.

Previously, when Visualfiles and Outlook Plus were installed for the first time, it was necessary to launch Visualfiles before running Outlook Plus, in order to write the API registry key. If this step was missed, and users tried to open a Visualfiles file from Outlook Plus, an error was returned and the attempt failed because Outlook Plus could not connect to the Visualfiles API.

This feature is supported by an updated Visualfiles Client Installer that delivers a new XML API configuration file and application:

- API Configuration File: VisualfilesAPIConfiguration.xsd
- ShortcutManager.exe

Now the API keys can be defined centrally in the XML configuration file and they work without being added to the registry.

## Basic Document Preview

A basic document preview capability has been introduced into core Visualfiles.

Basic Document Preview enables you to preview documents and other items in the file history, Document Review and Document Import areas of Visualfiles, without opening them in their native application. This feature is not intended to replace the comprehensive capability that is available with the existing Document Preview system module that uses Quick View Plus (QVP) software.

Basic Document Preview is included as standard with Visualfiles 3.3.0, so no additional licencing, installation or setup is required.

Spreadsheets	.xls, .xlsx
Rich Text Documents	.doc, .docx, .rtf, .htm, .html
Email Messages	.msg, .eml

## Windows 10 Certification

Visualfiles 3.3.0 has been tested with Windows 10 and is compatible.

Whilst Visualfiles has been certified against Windows 10, the underlying OpenEdge 11.5 SP1 has not been officially certified by Progress Software.
